ALLOTMENT AND ISSUE OF SHARES PURSUANT TO WARRANT EXERCISE

The Board of Directors of Marco Polo Marine Ltd (the “**Company**”) wishes to announce that the number of issued ordinary shares of the Company (excluding treasury shares) has increased from 3,520,168,361 ordinary shares to 3,520,328,361 ordinary shares by way of allotment and issuance of 160,000 new ordinary shares pursuant to the exercise of 160,000 warrants at the exercise price of S\$0.035 each on 5 July 2018.

These new shares rank *pari passu* in all respects with the existing shares of the Company, and will be listed and quoted on the SGX-ST on 9 July 2018.

Pursuant to the aforesaid exercise of warrants, there are 269,078,877 outstanding warrants each with an exercise price of S\$0.035 expiring at 5 p.m. (Singapore Time) on 29 January 2023.
