COMMENCEMENT OF SHIP REPAIR OPERATION AT SECOND DRYDOCK

Marco Polo Marine Ltd ("MPM" or "the Company") is pleased to announce that the second dry

dock (dry dock 2) at its shipyard in Batam commenced ship repair operation on 17 September

2009 with the docking of its maiden vessel, an accommodation barge.

Dry dock 2, with a specification of 175m x 40m x 8.5m, can dock merchant vessels of up to

25,000 dwt. In addition, this dock has a built-in pit (size 4m x 8m x 4m deep) especially for use in

the repair of retractable thrusters. The operation of dry dock 2 will complement the first dry dock

(specification of 150m x 40m x 8.5m) which was operational in April 2009. The two docks are

assisted by tower and crawler cranes of varying lifting capacities.

Because of the wide width of the two dry docks, they can easily accommodate specialised

vessels such as dredgers and accommodation barges. In addition to these specialised vessels,

the target market for the two dry docks are feeder container vessels, chemical tankers, coastal

tankers, offshore vessels, tugs and barges: vessels that commonly operate in this region or call

on the port of Singapore.

With the commissioning of dry dock 2, both dry docks will be operational for the whole of FY2010,

which begins on 1 October 2009. With the new ship repair facilities in full operation, the Group's

ship repair revenue is expected to increase substantially and ship repair operation is expected to

contribute materially to group profitability in FY2010.

In addition to ship repair, MPM's shipyard in Batam is capable of building sophisticated vessels

such as diving support vessels, rig tenders, subsea support vessels, AHTS and dredgers. The

shipbuilding operation also caters to in-house requirement by building tugs and barges for the

Group and its joint venture partner Glencore as well as AHTS for its other joint venture partners.
