Pursuant to the Investment Agreement entered into with MPML, Penguin announced on 8 November 2017 that it had agreed to subscribe for 357,142,857 shares in MPML. On 25 January 2018, Penguin set aside 53,571,429 shares pursuant to the MPML management share award plan ("Management Award Shares"). The first tranche of 17,857,143 Management Award Shares has been credited directly to two key members of MPML's management on 25 January 2018 following the signing of their service agreements. As such, the number of shares held (directly and indirectly) by Penguin as of 25 January 2018 is a total of 339,285,714 shares with 271,428,572 shares beneficially owned by Penguin and 67,857,142 shares held by Penguin as nominee for Mr Jeffrey Hing (Penguin's Executive Chairman and controlling shareholder).
