**ALLOTMENT AND ISSUE OF SHARES PURSUANT TO WARRANT EXERCISE**

The Board of Directors of Marco Polo Marine Ltd (the “**Company**”) wishes to announce that the number of issued ordinary shares of the Company (excluding treasury shares) has increased from 3,571,660,008 ordinary shares to 3,580,372,808 ordinary shares (excluding treasury shares) by way of allotment and issuance of 8,712,800 new ordinary shares pursuant to the exercise of 8,712,800 warrants at the exercise price of S\$0.035 each.

These new shares rank *pari passu* in all respects with the existing shares of the Company and will be listed and quoted on the SGX-ST on 26 January 2023.
